

Subject : Consultation to contribute to the Defence Omnibus Simplification Proposal

The European Commission Directorate-General for Defence Industry and Space (DG DEFIS) is currently collecting data, evidence and suggestions from stakeholders with the aim of (i) **removing regulatory barriers/discriminations** which affect the European defence industry (EDTIB) in EU-regulations and programmes, (ii) **simplifying and accelerating procurement procedures** for the EDTIB and to **simplify and facilitate transfer** of defence products in the Internal Market, as well as (iii) **simplifying EU defence programmes**, in particular the European Defence Fund (EDF). This initiative is called the "Defense Omnibus Simplification Proposal".

In this context, based on all previous EU assessments and EU defined goals (to be found, amongst others, in the 2016 Evaluation of EU 2009/43 Directive, the 2022 Versailles Declaration, the 2022 Strategic Compass for Security & Defense, the 2024 EDIS, the 2024 EDIP proposal, the 2024 Draghi report on the Future of European competitiveness, the 2024 EDA Annual Report, the 2025 Competitiveness Compass for the EU, the 2025 ReArm Europe Plan & Joint White Paper for European Defence Readiness 2030, and the 2025 SAFE proposal), it is our understanding that the Defence Omnibus Simplification Proposal shall focus on answering these **three key objectives**:

Objective 1: Building a strong, resilient and competitive EDTIB,

Objective 2: Simplifying the defence-related regulatory framework and raising awareness about it,

<u>Objective 3:</u> Developing a stable and facilitating environment for the EDTIB.

Prioritisation amongst these objectives is not recommended - on the contrary, these three key objectives need to be worked upon **simultaneously** for tangible results to be seen and thus, for the EU goals to be achieved.

By focusing on these three objectives, the EU could solve, or at least improve, the following **current issues**:

- 1. Technological gap (via Objective 1),
- 2. Dependency on non-EU countries (via Objective 1),
- 3. Under-investment in the defense sector (via Objective 3),
- 4. Lack of intra-EU collaboration (via Objectives 1 and 2),

- 5. Lack of SMEs' involvement (via Objectives 2 and 3),
- 6. Complex EU regulatory frameworks and divergent implementation (via Objective 2),
- 7. Trade barriers (via Objectives 1, 2 and 3), and
- 8. Heavy administrative burden (via Objective 2).

To do so, in our opinion, supported by numerous field experiences and feedback, the Defence Omnibus Simplification Proposal will need to **cover at least the following aspects**:

- 1. Lack of common definitions of key terms (e.g. "specially designed", "unfinished"),
- No consistency within and across EU export control regulatory frameworks (e.g. EU Regulation 2025/41, EU Regulation 2021/821, EU Regulation 2019/125, EU Directive 2021/555, EU Directive 2009/43, EU Directive 2009/81),
- 3. Current control of non-sensitive/non-strategic components,
- 4. Administrative burden in the context of intra-EU trade, including intra-group trade,
- 5. Divergent implementation of licensing exemptions under Directive 2009/43,
- 6. Divergent implementation of general licenses under Directive 2009/43,
- 7. Divergent classification and definition of controlled items,
- 8. Lack of awareness of the applicable regulatory frameworks and lack of user-friendly tools,
- 9. Overly prohibitive export control common criteria from the Council Common Position 2008/944/CFSP,
- 10. Trade barriers stemming from cross-sectorial EU laws and from EU competition rules,
- 11. No EU-First clause in procurement frameworks,
- 12. Negative public opinion and skills shortage,
- 13. Important delays in licensing processes,
- 14. Unwillingness of the financial sector to support the EDTIB,
- 15. Lack of resources within many national competent authorities,
- 16. Lack of intellectual property incentives and revenue-predictability in EU consortiums,
- 17. Lack of certified enterprises and mutual recognition,
- 18. Lack of digitalisation and lack of an EU-based sovereign cloud instrument,
- 19. Fragmented production and over-reliance on non-EU producers,
- 20. Trade barriers for start-ups and SMEs,
- 21. Trade barriers for the civil industry to get involved in the dual-use/defense sector.
