



Issue

Difficulty to have a single packaging satisfying all 27 Member States' individual requirements because so far, this topic was governed by an EU Directive (94/62) which allowed greater flexibility but led to **significant divergences within the EU**

Objective

Harmonising national measures on packaging and packaging waste in order to **avoid obstacles to trade** and the distortion and restriction of competition within the Union, while preventing or **reducing the adverse impacts on the environment and human health**

A. Materials

- **Substances in packaging:** limitation of the presence of heavy metals and substances of concern
- **Recyclability:** compulsory + performance grades A or B by 2038
- **Plastic packaging:** minimum recycled content + from specific installations
- **Reusable packaging:** compulsory for certain flows + re-use targets for grouped and transport packaging + reporting obligations

B. Dimensions & Format

- **Minimisation** requirements & **Performance** criteria
- Maximum **empty space** ratio

C. Declaration of Conformity

- **Technical documentation** requirement
- Declaration per packaging type
- In **languages** of territories where it is placed on the market

2. Packaging End-of-Life

A. Marking

- Harmonised **label** & QR code
- Manufacturer / Importer **identification**

B. Extended Producer Responsibility (EPR)

- **Registration** in each relevant Member State + **reporting**
- **Financial contributions**

Target Audience

- Applies to **ALL packaging** (regardless of materials used)
- Applies to **ALL packaging waste** (industry/retail/household origin)
- **No exemption** for the Defence industry
- Obligations based on the status (**manufacturer/importer/distributor of products in EU**)

Non-Compliant ?



- Packaged product can no longer be placed on the EU market !
- Sanctions → Recall / Rewithdrawal from the market
- Sanctions → Penalties

Expected from Member States by 12.02.2027

Key Dates



- 12.08.2026 – Entry into force
- 2030 : 1st reporting year on re-use targets

To Do

- **Collect** the identity of economic operators i) that supplies you with and ii) that you supply with, packaging or packaged products
- **Perform a gap analysis** of what you do vs. what is coming
- **Raise awareness** amongst your staff
- **Inform** asap your non-EU suppliers to discuss and **implement changes** earlier on
- Update your **policies & processes** (incl. recordkeeping)
